Preliminary report.

Vehicle #1 travelling EB at approximately 50 mph in left hand lane. Witness states he heard a loud snapping noise then a large portion of the tunnel roof swung down and struck roof of Vehicle #1, pushing it against left barrier. First officers on scene were Tprs. Sicard #2575 and Walker #2033, both from F loop. Upon arrival Tpr. Sweeney and myself find driver, Angel DelValle, walking around the scene with blood on his clothing. He was coherent, but talking in Spanish. We were told by the on scene troopers that there was a woman in the vehicle under the debris. Myself and Tpr. Sweeney crawled under debris and found no sign of life. All notifications were made. EMS personell later declared Milena Delvale deceased. Family notified.
